Dr. David Metzger Visits China as Part of HTPN Study

Dr. David Metzger left Philadelphia on May 13th at 10:00 AM for his 22 hour trip to China, to tour the HIV Prevention Trials Network (HPTN) sites there. Arriving in Bejing, the capital of China, Dr. Metzger managed to hail a cab in the 100 degree heat for the one hour ride to his hotel. The cab ride proved problematic because the cab driver spoke no English and Dr. Metzger does not speak Cantonese. Upon arriving at his hotel, Dr. Metzger met up with the other members of the site visit team, Irving Hoffman from University of North Carolina, Marybeth McCauley from Family Health International (FHI), and Kitty Poundstone, site coordinator at the Xinjaing site.

Dr. Metzger's first meeting was in Guilin and was sponsored by the National Institute on Drug Abuse. Guilin is a small town by Chinese standards although it is about the size of Philadelphia. The meeting in Guilin brought together representatives from six provinces in China who are interested in learning how to recruit and follow drug users for HIV prevention studies. There was a great deal of interest from public health professionals because studies like those conducted by Project RAP have not been done before in China. Until recently HIV/AIDS was not considered a serious problem in China and drug use was not publicly addressed. As in the United States, drug use is illegal in China, but officials estimate that between one and five percent of Chinese citizens use illegal drugs. Also, as in the United States, minorities are being hardest hit by the HIV/AIDS epidemic. In Western China, minorities who are native to the area suffer from the greatest poverty and lack of opportunity, and are also at the highest risk for HIV infection.

On one of the first days of his trip, Dr. Metzger visited a local public health building. The facility was called an "anti-epidemic station." A group of heroin users who had been requested to attend by the local neighborhood committee, met with Dr. Metzger to discuss drug use in China. They explained to Dr. Metzger that in China syringes are available in pharmacies for about one penny each, but that people still often shared syringes. While there are no open-air drug markets in China, drugs are still readily available. Heroin is the primary drug being used and it is estimated that half of the heroin users inject. This has led to high rates of HIV infection among drug users in several regions in China. HPTN sites have been located in two of these regions--Guangxi and Xinjiang. These sites are now involved in implementing a seroincidence study to determine the speed with which HIV is spreading among injectors. There are plans for staff from the Chinese sites to visit Philadelphia to learn about successful methods for conducting community based research.

Drug treatment options in China are severely limited. There are no methadone maintenance programs in China and no drug counseling outside of the "rehabilitation centers." Drug users are sent to "rehabilitation centers", run by the police, where they stay for three to six months. A typical day at the center includes exercise, work assignments, group discussions, and education. Dr. Metzger is hopeful that the HPTN will be able to conduct a prevention trial testing the impact of drug treatment in reducing the rate of HIV infection.

Prevention Point Philadelphia: Serving High-Risk Communities

Prevention Point Philadelphia (PPP) is a publicly funded community health program dedicated to



ealth program dedicated to reducing the transmission of HIV, hepatitis, and other bloodborne diseases in high-risk communities such as injection drug users and sex workers. PPP is operated by a professional staff and dedicated volunteers. The organization was founded in 1991 by community activists who were alarmed by the explosive rates of HIV/AIDS in high-risk groups in Philadelphia. The activists knew that the main route of transmission for HIV among

injection drug users was through the sharing of

syringes and other injection paraphernalia. To combat this, the ACT UP members began distributing new, sterile syringes to injection drug users so they would not have to share syringes and put themselves at risk. Clients returned used syringes for proper disposal. Originally the organization was underground because Pennsylvania State drug paraphernalia laws made it illegal to distribute syringes. In 1992 Mayor Ed Rendell signed an emergency

health order which allowed Prevention Point Philadelphia to distribute clean syringes and safe injecting equipment without fear of legal sanction. Prevention Point Philadelphia operates with an on-going contract from the City's Coordinating Office of Drug and Alcohol Abuse Programs and support from private foundations and corporations.

Prevention Point Philadelphia's office is located at 333 West Girard Avenue and the group runs six sites from its van at locations throughout the city. In addition to clean syringe exchange, Prevention Point Philadelphia offers a variety of harm reduction services to its clients. Prevention Point Philadelphia offers HIV testing at all the sites, and on Saturday and Monday at the harm reduction office. Case managers are available at three of the sites and at the harm reduction office to assist clients with referrals to drug and alcohol treatment, medical care, and other social services.

At the harm reduction office, a variety of support and eduction groups are available. On Monday evenings from 6:00 PM until 7:00 PM clients can attend the Life Management Group which offers clients an opportunity to get help and support with a variety of life problems. The Life Management Group also hosts the newly formed Prevention Point Philadelphia Legal Clinic which is organizing to address the legal issues of Prevention Point Philadelphia's clients. On Tuesdays Project TEACH conducts an HIV/AIDS education program from 3:00 PM until 5:00 PM. The Women's Support Group meets Wednesdays from 3:00 PM until 5:00 PM. Monday is Volunteer Day-volunteers help PPP with a variety of task from 12:00 PM to 5:00 PM. A meal and SEPTA tokens are provided for all group participants.

Spotlight on Chenita Johnson Frierson: RAP CAB

Chenita Johnson Frierson is the newest member of the Project RAP Community Advisory Board. She was accepted onto the CAB in May after attending CAB meetings for six months. Ms. Frierson is an Addictions Counselor in the Intensive Out-Patient (IOP) program at North Philadelphia Health System, at 8th and Girard. She previously worked with methadone clients and now works with forensic clients, who are courtstipulated to be in drug rehabilitation. Clients in the IOP program attend group meetings three times a week and meet with Ms. Frierson individually once a week. Ms. Frierson monitors each patient's progress in relation to their treatment plan and assesses the development of their peer relationships within the group setting.

Before becoming an Addictions Counselor, Ms. Frierson worked as a counselor for Good Will in South Carolina, working with people with disabilities. Good Will's primary purpose is to hire people with disabilities and place them in work situations where they can use their skills. Ms. Frierson worked with clients who had various physical and mental disabilities, helping them to find employment and lead more independent lifestyles.

Ms. Frierson moved to Philadelphia two and a half years ago when she married her husband who is a licenced Certified Public Accountant. She found out about the Community Advisory Board through a co-worker at North Philadelphia Health System who talked to her about the CAB and the various Project RAP research studies. Ms. Frierson, who is dedicated to helping others, thought that being part of the CAB would be a great opportu-

nity to help people at risk for HIV/AIDS and contribute to the community. Some of Ms. Frierson's client's were eligible for a Project RAP study, and after finding out more about the study, she referred several clients to the Project. She talked with CAB member JoAnn Williams and began attending meetings. She found the meetings interesting and informative and often passed out literature she received from the CAB to members of her work team at the Health System.

Ms. Frierson would like to see more public discussion about HIV/AIDS research and how individuals and communities can contribute, both in this country and abroad. She says, "It's sad how alot of countries don't care about people with HIV and don't do anything for them."

Spotlight on Janice Myers: RAP Staff

Janice Myers has worked for Project RAP for almost three years. Ms. Myers is a research technician who does phlebotomy, risk reduction counseling, interviews, and participant outreach. She has worked on numerous studies including VPS II, NEP, Substance P, LTLI, the Rapid Assessment Study for the Congressional Black Caucus, and WomenFIT. For the VPS II

study, she was the sole technician working with Annet Davis-Vogel on the study which looked at HIV risk factors for women who smoke crack cocaine. The study recruited 100 women and followed them for one year. The study had a 97.5% follow-up rate, continuing Project RAP's excellent track record for working with difficult-to-follow populations.

Before coming to work for Project RAP, Ms. Myers was a supervisor for a program providing services to emotionally disturbed and mentally handicapped adolescents. She also

works part-time for Thomas Jefferson University as a

Ms. Myers is a research technician who does phlebotomy, risk reduction counseling, interviews, and participant outreach. house manager at a facility for recovering mothers and their children.

Ms. Myers is a single parent of a beautiful daughter, Tahira, and the proud grandmother of two grandsons, Aquil and Kareem, aged 5 and 2.

Ms. Myers is currently working towards her bachelors degree in psychology at

Community College of Philadelphia, and will transfer to the University of Pennsylvania's College of General Studies in January. Ms. Myers currently spends most of her time at the RAP Office at 5th and Girard. Of her job she says, "I feel blessed, pleased, and grateful to be involved in HIV research because I lost a loved one to HIV. At that time I wanted to know all I could

about the disease. About four years later I entered the field of HIV research and one of my goals is to acquire as much information as possible and to help those who are at risk and/or already infected with HIV."
