



Outcomes of Consideration for Appointment and Promotions to Full Professor on the Tenure Track Perelman School of Medicine 2010-11 to 2020-21




Outcomes of Consideration for Appointment and Promotions to Associate Professor on the Tenure Track Perelman School of Medicine 2010-11 to 2020-21




Outcomes of Consideration for Appointment and Promotions to Full Professor on the Clinician Educator Track Perelman School of Medicine 2010-11 to 2020-21






Outcomes of Consideration for Appointment and Promotions to Full Professor on the Research Track Perelman School of Medicine 2010-11 to 2020-21






Years in Prior Rank at Time of Promotion

This information is provided by track (Tenure, Clinician-Educator, Research, and Academic Clinician) and by rank (Professor and Associate Professor).



Years at Prior Rank for Promotions to Full Professor on the Tenure Track Perelman School of Medicine 2010-11 to 2020-21




Years at Prior Rank for Promotions to Associate Professor on the Tenure Track Perelman School of Medicine 2010-11 to 2020-21




Years at Prior Rank for Promotions to Full Professor on the Clinician Educator Track Perelman School of Medicine 2010-11 to 2020-21




Years at Prior Rank for Promotions to Associate Professor on the Clinician Educator Track Perelman School of Medicine 2010-11 to 2020-21




