The inpatient pre-procedure retest window extends only to 14 days from the initial negative (admission) test, corresponding to the maximal incubation period of COVID-19 infection.

+ New Jersey Executive Directive 20-018 requires retesting each previously infected patient pre-procedure (specimen collected and result received) **once 6 weeks** have passed from the initial test date.
